2.5.2 Cancellation of Product

2.6 Payment Terms

- 2.6.1 Product will be billed directly by the Company on a monthly basis and is due and payable upon receipt or as specified on the Customer's bill. The monthly-recurring charge associated with the Product shall begin to accrue on the Acceptance Date of such Product as stated in the applicable Order Form and will continue until the expiration of the Order Form. Product will continue to be provided until canceled by the Customer or discontinued by the Company as set forth in Section 9.15.
